S. R. O. No. 728/2012.—In exercise of the powers conferred by sub-section (1) of section 2 of the Kerala Public Services Act, 1968 (19 of 1968), and in supersession of all the existing rules and orders on the subject, the Government of Kerala hereby make the following Special Rules for the Kerala Technical Education Subordinate Service, namely:—

RULES

- 1. Short title and commencement.—(1) These rules may be called the Kerala Technical Education Subordinate Service Special Rules, 2012.

- 5. Appointing Authority.—The Appointing authority in respect of all categories mentioned in this rule shall be the Director of Technical Education.
- 6. Reservation of Appointment.—The rules of reservation of appointments provided in the General Rules 14 to 17, Part II of Kerala State and Subordinate Service Rules, 1958 shall apply to appointments by direct recruitment.
- 7. Qualification regarding age.—No person shall be eligible for appointment by direct recruitment to the categories in column (2) of the table in Rule 3 if he has not completed 18 years of age and if he has completed 35 years of age on the first day of January of the year in which the application for appointment are invited with usual relaxation in upper age limit as provided in the Kerala State and Subordinate Service Rules, 1958 shall be allowed to candidates belong to SC/ST and Other Backward Classes.
- 8. Probation.—Every person appointed to a Class or Category shall, from the date on which he joins duty, be on probation,—
 - if appointed by Direct Recruitment or by transfer through Kerala Public Service Commission, or by transfer to a category for which Direct Recruitment is one of the methods of appointment, for a total period of two years on duty within a continuous period of three years;
 - (ii) if appointed by transfer to a category to which Direct Recruitment is not one of the methods of appointment for a period of one year duty within a continuous period of two years, and
 - (iii) if appointed by promotion, for a total period of one year on duty within a continuous period of two years.
- 9. Savings.—All persons who are members of this service as on the date of commencement of these rules shall be given exemption from possessing the qualifications prescribed by these Rules for the posts held by them as on the date of commencement of these rules.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

The qualifications prescribed in the Special Rules for certain posts of subordinate service of Technical Education Department needs to be changed with the latest developments in the field of Education. No Special Rules have been issued for certain posts so far and the service conditions of such posts are still governed by executive orders. In order to unify the existing rules and orders, Government have decided to issue Special Rules for the posts in the Technical Education Subordinate Service superseding all the existing rules and orders in the field.

At present, appointment to the post of Physical Education Instructor in Polytechnic Colleges is made by the Director of Collegiate Education through by transfer method from the seniority list prepared by Director of Public Instruction. Direct recruitment is not possible to these posts. This affects the quality of Education. The method of appointment and service conditions are to be specifically provided in the rules. In order to streamline the service conditions Government have decided to bring the post under the control of the Director of Technical Education and introduce direct recruitment in addition to "by transfer" appointment by prescribing a ratio 1:1.

This notification is intended to achieve the above object.
